COMPLAINT

REGENTS OF THE UNIVERSITY OF CALIFORNIA,

Respondent.

It having been charged by Charging Party that Respondent engaged in unfair practices in violation of Government Code section 3571, the General Counsel of the Public Employment Relations Board (PERB), pursuant to Government Code sections 3563(h) and 3563.2 and California Code of Regulations, title 8, section 32640, issues this COMPLAINT on behalf of PERB and ALLEGES:

- 1. Respondent is an employer within the meaning of Government Code section 3562(q).
- 2. Charging Party is the exclusive representative, within the meaning of Government Code section 3562(i), of Respondent's employees in the Academic Researchers Unit (hereafter, Unit).
- 3. Charging Party and Respondent are parties to a collective bargaining agreement (CBA) for the Unit that expired on September 30, 2022.
- 4. On or about May 3, 2022, Respondent informed Charging Party of a draft "Abusive Conduct" policy that when finalized would apply systemwide at all of Respondent's campuses, effective January 1, 2023 (hereafter, systemwide policy).

- 5. On or about June 3, 2022, the parties commenced bargaining for a successor CBA.
- 6. On June 10, 2022, Charging Party proposed language for a "Respectful Work Environment" contract article that addresses workplace safety and bullying, defines abusive conduct, and provides resolution procedures.
- 7. On June 29, 2022, Respondent provided a counter proposal conditioning agreement on the Charging Party's proposed language above with provisions in the to-be implemented systemwide policy, namely: (a) "If the definitions in this Article conflict with the [systemwide policy] at issuance or in future iterations, the new definitions will apply to this Article"; and (b) "Complaint procedures pertaining to Respectful Work Environment are covered by the [systemwide policy]. Except as described in this Article, if there is a conflict between such [systemwide policy] and this Agreement, the Agreement shall govern." Additionally, Respondent explained that it prefers to have consistency between all union contracts and the systemwide policy.
- 8. By Respondent's conduct described in paragraph 7, Respondent has refused to meet and confer in good faith, a "per se" violation of Government Code section 3571(c). Alternatively, by the "totality of the conduct" described in paragraph 7, Respondent indicated a lack of good faith or showed that it engaged merely in "surface bargaining," in violation of Government Code section 3571(c).
- 9. By the conduct described above, Respondent interfered with the rights of Unit employees to be represented by Charging Party in violation of Government Code section 3571(a).

Any amendment to the complaint shall be processed pursuant to California Code of Regulations, title 8, sections 32647 and 32648.
